Model Release & Waiver Agreement – Love Our Models

This Model Release & Waiver Agreement ("Agreement") is entered into by and between the undersigned individual ("Model") and Love Our Models, a division of Love Legacy Group LLC, an Illinois limited liability company ("Company").

1. Eligibility and Age Requirement

Participation is strictly limited to individuals who are 18 years of age or older. By signing this Agreement, the Model affirms and warrants that they are at least 18 years of age. The Company does not permit minors under the age of 18 to participate in any training, modeling sessions, events, or related activities. Any misrepresentation of age shall constitute a material breach of this Agreement and grounds for immediate termination of participation.

2. Grant of Rights

The Model irrevocably grants the Company and its representatives, employees, instructors, agents, contractors, licensees, successors, and assigns, the unrestricted, perpetual, worldwide right to:

- Photograph, film, or otherwise record the Model's image, voice, likeness, appearance, and performance.
- Use and publish the content in any format or media now known or later developed for commercial or educational purposes.
- Edit, crop, alter, or retouch the content, provided changes are not intentionally misleading or defamatory.

The Model waives any right to inspect or approve the finished content and acknowledges that no royalties or further compensation shall be due.

3. Assumption of Risk & Liability Waiver

The Model understands that modeling activities involve physical risks and voluntarily assumes all such risks. To the fullest extent permitted by Illinois law, the Model releases and holds harmless the Company from all claims related to:

- Participation in modeling activities;
- Injury or loss;
- Use of the Model's likeness in any form.

This includes claims for ordinary negligence but excludes gross negligence or intentional misconduct.

4. Independent Status

The Model is not an employee, agent, or partner of the Company and is not entitled to wages, benefits, or workers' compensation.

5. Representations and Warranties

The Model represents they are at least 18 years old, legally competent, and that their participation does not violate any other agreement.

6. Governing Law and Dispute Resolution

This Agreement is governed by Illinois law. Any dispute will be resolved through binding arbitration in Cook County, Illinois.

7. Severability and Entire Agreement

If any provision is found invalid, the remainder shall continue in effect. This is the entire agreement between the Parties.
